

Terms of Service

Introduction

These are the terms and conditions of use for www.tyktechnologies.github.io/montag-microsite/ (**Site**). The Site is operated by or on behalf of Tyk Technologies Ltd trading as Tyk (**we**, **us** and **our**). We are a limited company, registered in England. Our registered company number is 09727592, and our registered office is at 87a Worship Street, London, EC2A 2BE, UK. Our VAT registration number is 225560814.

Your use of the Site will be subject to these terms and conditions and by using the Site you agree to be bound by them. The software-related services we offer through the Site are provided subject to our software terms and conditions (**Software Terms**).

We reserve the right to change these terms and conditions from time to time by changing them on the Site. These terms and conditions were last updated on 14 November 2023.

Section 1 – Access to the Site

The Site is intended for use only by persons who are at least 13 years of age. By using the Site, you confirm to us that you meet this requirement and that, if you are under the age of 18, you have received permission from your parent or guardian before using the Site.

It is your responsibility to ensure your equipment (computer, laptop, netbook, tablet or other mobile device) meets all the necessary technical specifications to enable you to access and use the Site and is compatible with the Site.

We may, from time to time, restrict access to certain features, parts or content of the Site, or the entire Site, to users who have registered with us. You must ensure that any registration details you provide are accurate. If you choose, or you are provided with, a log-on ID (such as a username and password or other identifier) as part of our security procedures, you must treat such information as confidential and must not reveal it to anyone else. You are responsible for all activities that occur under your log-on ID and must notify us immediately of any unauthorised use or other security breach of which you become aware. We reserve the right to disable any



log-on ID, at any time, if in our opinion you have failed to comply with any of the provisions of these terms and conditions or if any details you provide for the purposes of registering as a user prove to be false.

We cannot guarantee the continuous, uninterrupted or error-free operability of the Site. There may be times when certain features, parts or content of the Site, or the entire Site, become unavailable (whether on a scheduled or unscheduled basis) or are modified, suspended or withdrawn by us, in our sole discretion, without notice to you. You agree that we will not be liable to you or to any third party for any unavailability, modification, suspension or withdrawal of the Site, or any features, parts or content of the Site.

Section 2 – What you are allowed to do

You may only use the Site for commercial and non-commercial use and only in accordance with these terms and conditions. You must only use the Site and anything available from the Site for lawful purposes (complying with all applicable laws and regulations), in a responsible manner, and not in a way that might damage our name or reputation or that of any of our affiliates.



All rights granted to you under these terms and conditions will terminate immediately in the event that you are in breach of any of them.

Section 4 – Intellectual property rights

All intellectual property rights in any content of the Site (including text, graphics, software, photographs and other images, videos, sound, trademarks and logos) are owned by us or our licensors. Except as expressly set out here, nothing in these terms and conditions gives you any rights in respect of any intellectual property owned by us or our licensors and you acknowledge that you do not acquire any ownership rights by downloading content from the Site. In the event you print off, copy or store pages from the Site (only as permitted by these terms and conditions), you must ensure that any copyright, trade mark or other intellectual property right notices contained in the original content are reproduced.

Whilst we do not pre-screen User Submissions, we reserve the right, in our sole discretion, to delete, edit or modify any User Submission submitted by you and/or to close any topic, at any time without notice to you.
